How to Enter:

You must be a Stillman Bank Debit Card holder as of the start date of this Promotion. There are two (2) methods of entry:

Entry Method 1 - Complete Transactions with your Stillman Bank Debit Card:

During the Promotion Period, use your Stillman Bank Debit Card to complete a card PIN or signature-based purchase ("Transaction") and you will automatically receive one (1) entry into the applicable Weekly Entry Period drawing associated with the date and time of your transaction (see Opt-Out process below if you don't want to be included in the Giveaway). A purchase or payment of any kind will not increase your chances of winning; see mail in entry method entry option below.
